Meeting Minutes:

Anthony provided a high-level overview of the new HHS/NTEU Collective Bargaining Agreement (CBA). The New CBA is a 5 Year agreement (the last CBA was a 3-year agreement) that among other rights:

- Documents remote work options instead of Memorandum of Understanding (MOU)
- Provides additional telework flexibilities
- Includes a new, mid-day flex option for Alternative Work Schedule (AWS)
- Increases child-care subsidy
- Student loan repayment oversight
- Provides up to 12 weeks of parental leave
- Allows temporary medical telework flexibilities

A comprehensive, summary of the new HHS/NTEU Collective Bargaining Agreement was provided to members before this meeting.



Summary of New HHS CBA Articles for

Anthony Lee asked for NTEU Chapter 282 Member support in voting for the ratification of the HHS/NTEU Collective Bargaining Agreement (CBA).

Anthony advised that all members of NTEU Chapter 282 received notice of this meeting on May 23, 2023. CDER NTEU Vice President, Amy Skinner made a motion that NTEU Chapter 282 Members vote ratify the new HHS/NTEU Collective Bargaining Agreement (CBA). Amy's motion was seconded by Sharrell Jackson and the motion was passed. There was a discussion between NTEU Chapter 282 members on the new CBA. After the discussion, Sarah Riger, the NTEU National Council conducted an electronic poll vote. The votes were as follows:
